ODDS would like to inform employment providers they are actively working with Centers for Medicaid and Medicare Services (CMS) on adjusting rates. ODDS has expressed that they are fully committed to this issue and are reevaluating with CMS on how to adjust without significantly impacting services. More updates will be provided on progress soon.
